6. Confirmation of the minutes of the previous GB – 63rd Annual state conference Madurai Previous TNOA - AGM minutes held during the 63rdAnnual state conference of TNOA VAIGEYE 2015 was read by the Hony Secretary and the printed Annual report booklet was circulated to all members.

8. Report of secretary TNOA presented by Dr.K.Rajasekar

10. Adopting the Audited report of the Previous 63rd Annual State conference of TNOA

Treasurer Dr.N.Rajeswari presented the VAIGEYE 2015 conference accounts audited report and thanked the organizers Madurai District Ophthalmic association for the contribution of Rs 12,65,067 (Twelve lakhs sixty five thousand and sixty seven) submitted to TNOA. Dr S.S.Sukumar enquired whether taxes have been paid for the said amt and Treasurer replied that it will be paid in a short time.

Treasurer also announced that once the taxes are paid and VELEYE accounts finalized the TNOA CONFERNCE Bank account will be passed over to the new LOC at Erode as per convention aiming at ONE account ONE pan card for all our conference accounts..

Previous conference accounts passed and accepted – Proposed by DrMathivanan Natarajan and seconded by DrMohdSayee

11 . Report of Editor Journal of TNOA 2015 – 2016 presented by Dr. T. Nirmal Fredrick

DrT.Nirmal Fredrick submitted that the new editorial team has taken over the office by April 2016 and brought out the first copy .He also announced his Editorial team lead by DrMuraliAriga Managing Editor ,DrRachula DanielAssociate Editor and young team of Asst Editors. He explained that the management committee had detailed discussion on many proposals to improve the Journal content and circulation and requested the GB to ratify the same specifically 1. Change of name to "Journal of Ophthalmic sciences and research" 2. Change to cover page and LOGO 3. To pursue and get Indexing, RNIregistration and ISSN registration with its budget 4. Archiving of all our journals in HTML form with its Budget 5. Maintain a editorial office with Professional executive with its budget 6. Like Full text to IJO similarly amend our byelaws to make it obligatory for all our conference submissions to go to TNOA Journal first. 7. To institute Journal awards to encourage more submissions every year.

President Dr K Vasanthaendorsed his views and said as the indexing process had been started even by the previous editor it is important for the growth of the journal and urged the GB to accept them. DrS.Sukumar suggested whether we need to give 15 days notice for constitutional amendment. DrV.Sidharthan cited the article 14 of the constitution naming the Journal .DrMathivanan said whether as a special case this can be passed.DrT.Nirmal requested the house to pass it by voice vote. Dr S.S.Sukumar asked whether separate website is needed. And its budget.DrT.Nirmal answered that the main TNOA websit will have a link to the journal site and will need 50,000 ruppees as one time cost with added maintenance cost every year. As the Indexing is along drawn process it will be started and pursued

Dr.Madhivananpointed out the delay in handing over to new editorial team for which DrKalpanaNarendran replied that even their office took over the journal only in august. DrK.Premraj pointed out that timely release of journals is a requirement for indexing and DrT.Nirmal Fredrick said that he will handover the office at the end of his term in time. Dr S Natrajan and Dr V Revathy supported the idea of indexing all journal copies and to request senior members and Institution libraries to give the older copies for indexing and help.

DrS.B.Sivathanu raised a point of not receiving jounal. Secretary Dr.KRajasekar clarified that the address database is maintained at the secretary office and all the 2350 addresses are posted for journals, Election notification, GB notification etc, Of these 167 return as wrong address. So when there are two or three return copies that address is removed from the excel sheet and will be put in the website as an address need update link. So if you are not getting journal or communication from secretariat please check the website whether your address is there and get it corrected.

Financial Performance Highlights

We have a made a major shift in our accounting. This is the first time we have integrated conference accounts as part of TNOA financial reporting.

We have achieved a Total Revenue of Rs.1.27 Crores and Net Income of Rs.2.16 Lakhs. VELEYE has contributed a Net Income of Rs. 6.88 Lakhs which is way below the budgeted revenue of Rs.12 Lakhs. Service Tax Liability of Rs.11.25 Lakhs for VELEYE is yet to be paid. We have taken a loan against an FD to the tune of Rs.15 Lakhs to meet the expenses of the Association covering the shortfall of revenue. We have paid a sum of Rs.30 Lakhs to AIOS by breaking a FD. Our FD savings stands at Rs.53.06 Lakhs.

Operations Summary

- Service Tax Registration is completed. Service tax collection was implemented first in VELEYE conference.
- TNOA Conference Account transferred to EROVISION 2017. All collections and payments will be managed by the conference management committee. Audited Income and Expenditure statement will be provided to the Treasurer's office after the conference.
- We are still registered as a Trust with Income Tax. We are working with our auditor to change our registration to Association. But this is proving to be a difficult task.
- · We have responded to notices received from Income Tax Department and Service Tax Department to pay tax dues.
- IT 12A Registration is in progress.
- Pay U Money was rolled out during the VELEYE conference. Collection through this channel was Rs. 9.58 Lakhs

Observations

- Financial Performance for FY 2016-17 is probably one of the lowest. Expenses have significantly increased without corresponding increase in revenue. We are breaking FDs to fund the gap.
- The current trend of using FD to fund expenses will deplete savings in 2 3 years.
- Reconciling conference invoices with payments has been difficult. Verbal confirmation and improper documentation has been the prime reason for this.
- · We need a Registered Office Address for TNOA for all Statutory Registrations and Communication. We need to produce proof of address as we go through the process of such registrations for TNOA.
